Directions

From the North (West of Bellmore)

- 1) Meadowbrook Parkway to SOUTHERN STATE PKWY East.
- 2) Get off at NEWBRIDGE ROAD(south) (Exit 25S). Make RIGHT TURN onto NEWBRIDGE ROAD (south).
- 3) Cross Jerusalem Ave and continue past RITE STOP on Left to BELLMORE AVE. (2 traffic lights) At BELLMORE AVENUE make a LEFT TURN (south).
- 4) Travel south on BELLMORE AVENUE 1 mile to WHITE PRESBYTERIAN CHURCH on left. Go about 1 ½ more blocks to office on left.
- 5) Office is on the left in the BELLMORE FAMILY MEDICAL ASSOC. Building (a CREAM BUILDING with BROWN trim). Parking is available in the rear.

From the North (East of Bellmore)

- 1) Wantagh Parkway to SUNRISE HWY West.
- 2) Travel west on Sunrise Hwy to Bellmore Avenue (King Kullen Shopping Center on far left corner).
- 3) At BELLMORE AVENUE make a RIGHT TURN (north). A King Kullen Shopping Center will be on the far left corner and the Bellmore LIRR station is one block ahead on the right.
- 4) Continue for TWO LIGHTS AND ONE BLOCK. Office is on RIGHT in the BELLMORE FAMILY MEDICAL ASSOC. Building (a CREAM BUILDING with BROWN trim).

or

- 1a) Wantagh Parkway to Southern State Parkway (west) to NEWBRIDGE ROAD (south) exit. Follow directions for "West of Bellmore" above #3-5.

From the South

- 1) Use either Wantagh or Meadowbrook parkways to get to SUNRISE HWY and then follow above directions.

From the Bellmore LIRR Station (Babylon Branch)

- 1) Walk to Bellmore Avenue (the MAIN street just east of train platform).
- 2) Turn left (north) onto BELLMORE Ave and walk about 3½ blocks to office (on right side of street).

From South Queens & Brooklyn

- 1) Take Belt Parkway to Southern State Parkway and Follow FROM THE NORTH (West of Bellmore) #2

OR

- 1) Take Sunrise Highway to Bellmore Avenue (King Kullen on right, Bellmore LIRR Station on left)
- 2) Make left (under train tracks) onto Bellmore Avenue. Go 4 blocks to office on right **"Bellmore Family Medical Associates"**

From the East

To get to my office (which is in a residence) take the

- (1) Northern Parkway (west) to Long Island Expwy. Skip to # 2 (OR)
Northern Parkway (west) to EXIT 24. Go north on Little Neck Pkwy (right Turn) until you pass under the Long Island Expwy. Skip to # 3
- (2) Long Island Expressway (west). Exit the LIE at EXIT 32, Little Neck Parkway. Make a right turn at light onto Little Neck Parkway (north)
- (3) **Follow Little Neck Parkway (North) for 4/10 of a mile from the Long Island Expressway. Make a left turn onto BRATTLE AVENUE (this is really a fork in the road) that makes it more like a "U" turn. The landmarks for this turn are a stockade fence on the left, a church parking lot on the right, also just past North Shore - Queens Eye Medicine on right . [If you reach a traffic light at this point you have gone about 150 feet too far).**
- (4) **Continue on Brattle Avenue for about 75 feet into another intersection. Make a *sharp right* onto LEITH ROAD. My office is in the fifth house on the right -- 252-61. It is a white house with black shutters that does not look like any of the other houses.**

From the West

- (1) Take Long Island Expwy (east) . Exit the LIE at EXIT 32, Little Neck Parkway. Make a LEFT TURN onto Little Neck Parkway (north)
 - (2) Now Follow Directions Above from #3
- [OR]**
- (1) Take Grand Central Pkwy (east). Exit the GCP at EXIT 24, Little Neck Parkway. Take Little Neck Pkwy north, a left turn. Continue until you pass under the LIE, then follow from #3 above.

From the North (N. Queens, Bronx, Westchester)

- (1) Take Cross Island Pkwy (south) to the Long Island Expwy (I495) East. Follow "From the West"

From the South (S. Queens, Bklyn)

- (1) Take Belt Pkwy (east) to the Cross Island Pkwy (North).
- (2) Take Cross Island Pkwy (north) to the Long Island Expwy (I495) East. Now Follow "From the West" Section Above.

From the Long Island Rail Road (LIRR) Little Neck Station

- (1) LIRR from Penn Station in NYC to Little Neck Station. This is the Port Washington Line.
- (2) Take a Taxi from the Taxi Stand to my office using the following route:
- (3) Follow Little Neck Parkway (South) to Northern Blvd. Continue on Little Neck Pkwy for two (2) more traffic lights and about 75 feet. Make a right turn onto BRATTLE AVENUE (this more like a fork in the road). The landmark for this turn is a red brick church on the left.
- (4) Continue on Brattle Avenue for about 75 feet into another intersection. Make a *sharp right* onto LEITH ROAD. My office is in the fifth house on the right -- 252-61. It is a white house with black shutters that does not look like any of the other houses.
